School Matters: Regina Lauricella

Academic Data

- Mrs. Lauricella presented using a slide show using data on 2nd graders. Comparative data is PARCC which will no longer be used as the statewide assessment. (Please see attached presentation for additional information.)
- Students currently tested 3 times a year using MAP.
- Literacy: In November 43% of second graders below benchmark, March 21%. School met goal set last year by principal and teachers for performance.
 - Above benchmark November 12%; March 31%
 - Next step in analyzing data is to breakdown who is in each group
 - When benchmark is taken it is compared to where student should be at that point in the year
 - Compared to State and District:
 - Projection show that 42% of our students would meet/exceed expectation
 - Currently percentage of students proficient: State 52%, District 25%
- Math: seeing a lot of math growth.
 - Proficiency compared to State and District:

■ State: 53% ■ Paterson: 25%

■ 1 atc13011. 25 /0

■ PACS Paterson: 45%

- Foundations for success:
 - Strong curriculum and instruction
 - Teaching students test taking skills
- Currently implementing:
 - LLI Intervention
 - Tutoring (before, during and after school)
 - Three time a year MAP assessment
 - Writing about reading
 - Intervention and Enrichment block
- Kindergarten comparisons in March of students below benchmark:

0 2017: 36.5%

0 2018: 33.80%

0 2019: 29.30%

- Have seen great results from implementing LLI program
- This year will host 4 week summer program with self-created curriculum
- Adding 2 week intensive tutoring program for rising 3rd graders in August

Summer Program

- Morning Academic Focus (105 spots)
 - Rising 1st (2 sections)
 - Rising 2nd (3 sections)
 - Rising 3rd (2 sections)
- Afternoon Enrichment Opportunity
- Rising 3rd Grade tutoring program
 - o Smaller class size
 - ½ day program
 - Intense focus on literacy and 2nd grade math standards (review)

- Today was Earth Day: great day with many activities throughout school
- Parent conferences very successful. High parent participation.
- Recommend that when Easter falls later in April we add a date in the calendar earlier in March or April to provide students and staff with a break.
