#### GOVERNANCE

- Audit Presentation: Scott Loeffler, CPA
  - Review of the balance sheet for fiscal year ending June 20, 2018
  - o Audit procedures include review of all reporting to the state as well as bank reconciliations (done at PEP level for Paterson)
  - o Discussion around keeping a healthy total fund balance as a financial safety measure for the school, and to provide flexibility for growth/cash flow (i.e. unexpected costs that may arise unanticipated or unallocated to original budget)
    - Recommends maintaining fund balance even for a growing Charter school
  - Overall, there were no recommendations; numbers were streamlined and seamless to calculate; growth will make this more complex
  - o PACS Newark currently incurs all the costs for lunch system for both locations, but also absorbs all the funding; this is currently more cost-effective

## SCHOOL MATTERS/PRINCIPAL'S REPORT

- Attendance: Thea Heninger-Lowell
  - Total attendance percentage increased in February
  - Comparison: 18/19 AY attendance %s are right on par with 17/18 AY attendance for K and 1<sup>st</sup>
  - Process for meeting with principal in advance regarding travel arrangements to combat attendance issues

#### Enrollment/Lottery

- o Lottery to be held Wednesday, March 13th, 10:00 AM
  - Process will consist of 48 hours of notifying families, and then scheduling registration appointments for early April
- Application window is now officially closed; any applications received after February 22<sup>nd</sup> entered into waitlist
- Current re-enrollment contracts: 100%
- o 3<sup>rd</sup> grade vacancies will not be filled due to expansion to ensure proper resources as changes occur; may be revisited during Summer

### **Principal's Report:** Sandra Harrison

- Recent events:
  - Winter Family Fun Night occurred Thursday, February 21<sup>st</sup>;
  - o Many readers participated in Read Across America
  - o Kindergarteners experienced Liberty Science Center
  - o Math Talk Workshop on problem-solving
- Results for Literacy Intervention Program have been reviewed and students are being grouped according to their needs to ensure supplemental resources are provided if necessary
- Planning Professional Development Trainings
- Analysis of MAP data is ongoing (identifying areas of strengths and weaknesses)
- Report cards are being finalized; Q3 grades to go out March 21<sup>st</sup>; parent conferences to take place last week of March
- Continuing process of meeting with parents with vacation plans during school year

#### PEP UPDATE: MARCY BOSTWICK

- Main area of focus remains facilities search; in process of working on zoning stipulations and reviewing lease
- Ongoing site search for incoming Kindergarten class

**Discussion on Budget** in preparation for next meeting: Migdalia Dale (School Business Administrator)

- Received numbers from state for 19/20 AY (projected based on enrollment)
- Discussion around what percentage/amount should be allocated to fund balance
- Discussion around source of PEP Startup grant (Special Revenue) and confirmation of grant funds
  - o Migdalia notes this needs to be a discussion between PACS Paterson and PEP boards
- Board asked the SBA/Migdalia to prepare the budget based on known and confirmed funding from the federal, state, PEP grant, and or any other fund source
